Permission is granted to Participant to receive emergency medical treatment, if needed. I also agree to indemnify and hold harmless those listed above for all claims arising out of Participant's participation in the program and all related activities. I agree to let the parties use Participant's name and likeness free of charge in any manner and for any purpose without compensation to me or Participant. I understand that this document is intended to be as broad and inclusive as permitted by the laws of the state in which the program is taking place and agree that is any portion of the Agreement is invalid, the remainder will continue in full legal force and effect. I further agree that any legal proceedings resisted to this waiver will take place in New York, New York.
